Frequently asked questions

Q. Who can access the app?

A. UBS equity plan participants with the following can access the UBS Financial Services Inc. app at this time:

- A custom username
- iPhone 11 or a higher version
- Android phone with version 10 or higher


Participants who have not yet created their custom username will need to complete this process on the full UBS One Source website before being able to use the app.


Q. Is the app only available for mobile phones?

A. Yes, the app is currently only available for mobile phones. Access for tablets will be implemented in the future.

Q. How do I download the app?

A. Visit the Apple app store or Google Play store and search for "UBS Financial Services Inc." Once the app appears, select "GET" or "INSTALL" to download the app.





What should I expect the first time I log in?

A. Use your custom username and password to log in. You will be prompted to request and enter a temporary PIN, the same process you would complete when using the UBS One Source website for the first time from a new desktop device. Once you receive the PIN, enter it in the app. Participants who have not yet created their custom username will need to complete this process on the full UBS One Source website before being able to use the app.













Q. Is the app secure?

A. Yes. For security purposes, when using the app for the first time from a new device, you will be prompted to request and enter a temporary PIN. Once you receive the PIN, enter it in the app. When logging into the app going forward, you will be prompted to enter your One Source username and password.

Q. How much does the app cost?


A. There is no cost to download or use the UBS Financial Services Inc. app.


Q. What can I do in the app?

- Upcoming events






